## GUARANTEED ACCESS TO THE NETJETS FLEET

Supplemental Lift Assurance™ (SLA) provides you guaranteed last-minute access to the NetJets® fleet without committing to a specific aircraft type.

Other benefits include:

- Access to select NetJets' light and midsize cabin aircraft
- 4-hour response time on most domestic flights<sup>1</sup>
- Specific aircraft type guaranteed with at least 10 hours' notice<sup>1</sup>
- Dedicated Owner Services Team on call 24/7
- No pre-specified number of flight hours and no long-term commitment

## ACCESS NETJETS WITH LOWER UPFRONT COSTS

The upfront deposit is \$25,000. You'll pay an hourly rate for flight time and fuel, which will be based on the aircraft type provided. Flight activity will be deducted from your deposit and when depleted, you'll be invoiced monthly for your flight activity going forward.

Convert to a NetJets Share or Jet Card at any time. NetJets will apply the remaining balance of your deposit as a credit towards your purchase of a NetJets Share, Lease, or Jet Card at any time during your SLA contract.

## GUARANTEED RESPONSE TIME

With SLA, you're guaranteed a light or midsize aircraft on flights originating and terminating in the continental United States with as little as 4 hours' notice. With 10 hours' notice you have the benefit of selecting the specific aircraft type desired which also means you know the exact cost of your flight upfront.

For flights from the continental United States to Bermuda, the Caribbean, and select Canadian cities<sup>2</sup>, or from the select Canadian cities to the continental United States, the required notice is 12 hours. For flights from Bermuda or the Caribbean to the continental United States, the required notice is 24 hours.

There is a one-hour minimum segment duration. There is no usage limit, and requests for multiple aircraft per day are subject to availability. Cancellation fees apply for flights cancelled within the response time. Other fees include taxes, fuel, international fees and services, and ancillary charges (e.g., ground transportation). All flights are flown under FAR Part 135.

<sup>1</sup> Additional notice required for international or flights departing before 10 a.m. local time. Additional terms and restrictions apply on NetJets Peak Period Days (PPDs). On PPDs, a 25% multiplier is applied to billed flight time and at least 6 hours' notice is required.

<sup>2</sup> Select Canadian Cities means: Vancouver in British Columbia; Hamilton Kingston, Kitchener, London, Muskoka, Ottawa, Peterborough, Sarnia, St. Catharines, St. Thomas, Stratford, Toronto, and Windsor in Ontario; and Montreal in Quebec.
